Tonoring Legacy, Service, and Unity: Celebrating Black History, Women in Service, and the Strength of Our Legion Family



Greetings, Department of Maryland Legion Family, As we step into the months of February, March, and April, we are reminded of the rich history, remarkable contributions, and unwavering dedication of those who have served our nation, both in uniform and beyond. February marks Black History Month, a time to honor the sacrifices, leadership, and achievements of African Americans throughout our history. March is Women's History Month, where we recognize the pioneering spirit, resilience, and service of women in the military, Department of Defense civilian workforce, and veteran community. March 15 marks the birthday of The American

Legion, celebrating 105 years of service and advocacy for veterans, their families, and our communities. March 29 is National Vietnam War Veterans Day, a time to honor and remember those who served during the Vietnam era and to ensure their sacrifices are never forgotten. Finally, as we look to April, we prepare to celebrate Legion Family Day on the last Saturday of the month, recognizing the strength, unity, and shared mission of our Legionnaires, Sons, Auxiliary, and Riders as we continue serving those who served.

African Americans have played a pivotal role in shaping our nation's history, from the brave men of the Buffalo Soldiers and the Tuskegee Airmen to modern-day leaders in service, innovation, and advocacy. Here in The American Legion Department of Maryland, we proudly honor the trailblazers who have made a lasting impact, including Past Department Commanders Robert Johnson, Leroy E. Thornton, Melvin G. Smullen, and Ronald L. Holcombe, along with many others, who have exemplified the values of service, sacrifice, and leadership-ensuring that the voices of all veterans are heard, respected, and empowered.

Women have also been an integral force in our nation's defense, serving with honor, courage, and distinction in every branch of the military. Since the Revolutionary War, more than 3 million women have served in the U.S. Armed Forces-many giving their lives in the service of our country-and their unwavering dedication has helped redefine what it means to be a patriot. Their sacrifices, both seen and unsung, remind us that freedom is often secured at a profound cost.

One striking example of this indomitable spirit is embodied by the Hello Girls, the pioneering female telephone operators of World War I. These brave women were tasked with establishing and maintaining secure lines of communication amid the chaos of war. In a time when clear, reliable communication was a matter of life and death, the Hello Girls not only bridged critical gaps between command centers and the battlefield, but also shattered prevailing gender norms. Despite facing skepticism and initial exclusion from official recognition, their essential contributions eventually earned them the honor they deserved-affirming that the strength and skill of women are indispensable assets to national defense.

Today, as we celebrate Women's History Month, we also recognize the historic service of the 6888th Central Postal Directory Battalion-the first and only all-Black Women's Army Corps unit to serve overseas during World War II. These women were charged with the monumental task of clearing a massive mail backlog that had stalled, thereby ensuring that morale-boosting letters and packages reached American troops at the front lines. Despite overcoming racism, sexism, and the challenges of wartime logistics, the "Six Triple Eight" completed in six months what was originally estimated to take a year. Their story, now brought to life in the newly released film The 6888, serves as a powerful reminder of the unwavering resilience, dedication, and impact of women throughout military history

The American Legion, Department of Maryland Black History Month Honoring our African American Veterans, Historically **Black Posts. and Department Leaders**

This is our sixth anniversary of publishing an **L** article highlighting the achievements of Black Veterans and Historically Black Posts in Maryland. This year we will mix in Women Veteran history updates as well because March is Womens' history month.

This year the Department continues to pay honor and tribute to these deserving Veterans and hopes that the information shared highlights and educates our members about the deep history and record of service of the Posts and Veterans in/from Maryland, the Black communities, and at the Department level within The American Legion. The space available for this article is limited and all efforts are being made to include as much detail as possible, the extensive histories are far deeper than we could cover in a few pages. All are encouraged to continue to investigate and expand their knowledge of the stories. This year the article will update on the 6888th Central Postal Battalion ("Six Triple Eight") and the long overdue recognition they are receiving, then we will briefly discuss the Harlem Hellfighters being awarded the Congressional Gold Medal, and finally the awarding of a special Congressional Gold Medal for the Hello Girls of WWI.


For those who have a Netflix account or those who were watching entertainment news in December of last year, the trending movie on that platform was a familiar group of Veterans to all of us in the Department. The Six Triple Eight, written and directed by Tyler Perry, took

the streaming app by storm in December. The riveting portrayal of the Veterans of the 6888th and their ground-breaking accomplishments during WWII is a must watch for everyone. Many may not know but a leading champion of the 6888th is our very own Elizabeth "Lizz" Helm-Frazier of Greenbelt Post 136. Lizz was on the set of

the film and encouraged Mr. Perry to make sure the film portrayed the story of the unit and the struggles for the world to better understand what was achieved by these approximately 855 women. Lizz has worked tirelessly with other champions to ensure these women and others are recognized in every way possible. She regularly updates me on the efforts and welcomes others to take up the banner and make sure our Veterans stories are preserved for the ages. I will not provide any spoilers for the movie, but those who joined us in 2021 at the Department Convention or who saw the documentary from 2019 surely know how the story unfolds.

The power of the movie is the underlying story and humanity. It makes the struggle and perseverance real from the eyes of the Veterans who accomplished the overwhelming mission they were handed, and the hopes by many that they would fail and thus prove African-Americans generally and African-American women in this specific instance were not up to par with their counterparts serving in the Armed Forces. The performance of the star - studded cast include Oprah Winfrey as Mary MacLeod Bethune along with Sam Waterson and Susan Sarandon playing the Roosevelts. The film is up for one Oscar for "Best Original Song" for the featured song "The Journey" and scored five NAACP Image award nominations including Outstanding Actress for Kerry Washington who portrayed Maj Charity Adams and Supporting Actress for Ebony Obsidian for her role as Lena Derriecort Bell King. Lizz also reported that Mr. Perry had a special draft of the film sent to the real Mrs. King to view before her passing in January 2024. While not the finished product Mrs. King was happy to see the portrayal and shared her happiness with Mr. Perry.

The unit still has two surviving members we are aware of at the time of this writing, Fannie Griffin McClendon who went on to serve in the US Air Force after her service in the 6888th and retired as a Major has a delightful oral history online at the Library of Congress website and recently turned 104 at her home in Tempe, Arizona. The other surviving member is turning 101 on

NEC Report Melvin G. Smullen, National Executive Committeemen

Textend my greetings to all on behalf of our National Commander Jim La Coursiere Jr. The National Commander will officially visit the Department of Maryland on March 15th and 16th. The Spring National Executive Committee will not be held until May the 7th and 8th. Under old business of the NEC, I received an email from National on 1/31/2025 reference Resolution #1 Reinstatement of the Charter of the American Legion Department of Washington. The resolution is from the Subcommittee on Resolutions which seeks to return the charter of the Department of Washington, subject to various benchmarks included in the resolution. It was a vote to approve the "Reinstatement of the Charter of the American Legion Department of Washington." Hopefully, the decision was made on February 15, 2025. We will be informed. Veteran Suicide Prevention continues to be the American Legion Number One Concern. In accordance with January/February Army Times Volume 86., suicides among veterans remain unchanged despite Federal Focus. "Every Veteran Suicide is a tragedy." There is nothing more important to all of us than ending Veteran suicide, and that means providing veterans with the care they need, wherever they need it and whenever they need it. Unfortunately, even Military Suicide increased again in 2023, continuing a steady and concerning rise in self-inflicted deaths among service members.

It has been brought to the members of the DEC during a prior meeting that the Department of Maryland must be more tentative about issues that impact on both veterans and the military; followed by developing resolutions to support your action. The Department of Maryland has not recently been supportive of this endeavor. Please do not hesitate to attempt to write a resolution. We just need the idea and help in writing the resolutions will be provided. It is

suggested that resolutions be only one page as you lose your audience when they become too wordy. It was also brought up at the DEC that Military Retirees are the only federal retirees to waive a portion of their retired pay to receive VA Disability Compensation, while all other Federal Employes are

permitted to receive both retirements pay disability compensation concurrently. Well! I know now that Senator Chris Van Hollen of Maryland is working diligently on this issue. He is the co-sponsor of the Major Richard Star Act, which would allow disabled veterans to receive both their retirement pay and their disability compensation, concurrently.

Several posts throughout the state of Maryland and other states normally sponsor programs during the month of February to honor the four Chaplains. No words can better explain the story of the four chaplains who sacrificed their life on February 3, 1943. (Rev. George L. Fox, Reform Rabbi Alexander D. Goode, Catholic priest Father John P. Washington, and Reformed Church in America Minister Rev. Clark V. Poling. They all served as US Army Chaplains in the first year of World War II. It has been said several times that "There is no greater love, says the Lord, than to lay down your life for a friend." Finally, I want to say Happy Birthday! March 15 is the designated birthday of the American Legion. On that date in 1919, the first American Legion Caucus held by members of the American Expeditionary Force, convened in Paris.

CALL FOR THE 107TH ANNUAL CONVENTION TH

The One-Hundred-Seventh Annual Convention of The American Legion, Department of Maryland, Inc., is hereby called, and in conformity with the action of the One-Hundredth-Sixth Annual Convention and the Department Executive Committee, will be held in Ocean City, Maryland, Tuesday, **July 15** through Friday, **July 18, 2025**.

PURPOSE

The Convention is called for the purpose of electing officers for the ensuing year, hearing and considering resolutions, and for the transaction of such other business as may be deemed necessary to come before the Convention.

REPRESENTATION

The Department Convention shall be comprised of representatives from each Post who shall be members in good standing of the Post by which they are elected, and all Past Department Commanders while in good standing in their respective Posts. Each Post having 15 members in good standing shall be entitled to two Delegates. Each Post having 26 members in good standing shall be entitled to three Delegates and to an additional Delegate for each additional fifty members after the first twenty-six. Each Post shall be entitled to an Alternate for each Delegate. Membership strength of the Post, for determining Delegate strength, shall be computed as of paid-up membership in Department Headquarters at the close of business on June 10, 2025

All Department and all National Officers listed in ARTICLE VI, Section 1 of the Department Constitution in the year in which they serve (excluding the Department Adjutant if serving as an employee of the Department), and all Past Department Commanders, shall be Delegates-at-large to Department Convention, with right to vote thereat, to be exercised by them with their respective Posts. Every Post shall file the name and number of the Delegates and Alternates to the Department Convention at least twenty days prior to the convening of the Convention, (no later than June 25th this year), and at the same time pay the registration fee of \$20.00* for each and every Delegate, in the case of an Alternate taking the place of a Delegate such Alternate shall be required to pay the registration fee of \$20.00* which shall be done when the substitution takes place or sooner; unless and until such registration fees of the Delegates have been paid, the Delegation is disqualified to act for any purpose, and no individual Delegate will be allowed to vote, provided, however, that the mere non-payment of registration shall not deprive a Delegate otherwise duly qualified, of the right to vote in any Region or District Caucus, on any matter (including election of officers) which thereafter is subject to ratification by the Department Convention. Post Commanders are urgently requested to have at least one member of their Delegation on the Convention floor at all times. *Cost of Delegates will be \$30.00 on or after June 26th.

VOTING

Department Constitution, ARTICLE V, Section 3 (a) On all matters of business except the election of

- Department Officers, members of the DEC and Delegates and Alternates to the National Convention, and except amendments to this Constitution or the By-Laws, voting shall be by voice. The decision of the chair thereon shall be final unless a vote by roll call be demanded; and upon demand of any person having proper voice, such other manner of voting shall be employed.
- (b) The election of all Department Officers, and National Officers, shall be by roll call except where, in the

case of individual offices, the necessity of a roll call is dispensed with by unanimous consent.

- (c) The election of members of the DEC, and Delegates and Alternates to the National Convention, shall be in accordance with such rule as adopted by the Caucus in and for the Region from which such members, delegates and alternates are elected, but in no case, shall any such rule prevent the nomination of any member from the floor of such Caucus by any person having proper voice thereat. Voting at Caucuses shall conform to the provisions of Subsection (d) hereof.
- (d) In all voting, the vote of each Post shall be equal to the total number of delegates to which such post may be entitled. Each delegate shall be entitled to one vote. The vote of any delegate who may be absent shall be cast by the delegate's alternate, and the vote of any delegate absent and not represented by an alternate shall be cast by the majority of the present delegates from the member's post. An alternate whose delegate is present may nevertheless move into the place of an absent alternate whose delegate also is absent, and thereby acquire the right to vote, provided said alternate delegate is the senior alternate present at the time. Alternates shall have all the privileges of delegates but may only vote as herein set forth; provided the alternate's registration fee is paid. At the conclusion of all roll call voting, for each individual election required to be conducted by the Department Convention, the Department Officer conducting such elections shall ask if any Post desires to amend or change its vote; or ask does any Post, which has not cast its vote during the roll call vote, now wish to cast its vote. No Post shall be allowed to pass more than one time. After the Department Officer conducting the election has made the aforesaid announcement and taken due note of any changes in voting and has recorded the vote of any Post which originally passed, then the conducting officer shall announce that the voting is closed and direct that the tally be taken, and the results announced.
- (e) All Past Department Commanders, while in good standing in their respective Post, shall be delegates for life to all Department Conventions with voice and vote, to be exercised by them with their respective Post and all Region or District Caucuses at which any election provided for in this Constitution shall be held, and at which their respective Post may be entitled to vote. The failure of such Post to properly register its delegation shall not deprive such Past Department Commander of their right to vote, provided the Past Department Commander is properly registered as a delegate.
- (f) All Department Officers as set forth in Article VI of this Constitution, with the exception of Department Officers concurrently serving as a paid employee of the Department, and National Officers of this Department shall be Delegates-at-large to Department Conventions, with the right to vote thereat, in the year in which they serve, to be exercised by them with their respective Post; provided, however, that nothing contained herein shall give any person the right to more than one vote.

The following Officers are to be elected. A majority of the authorized vote of the Convention shall elect: (Per ARTICLE V, Department Convention Section 4) **Section 4 (a)** The Department Convention shall

elect a Department Commander, a Department Senior Vice-Commander, a Department Judge Advocate, and a Department Treasurer, a National Executive Committee member and an Alternate National Executive Committee member for the respective terms for each office as specified in Section 4b hereof. The Department Convention shall elect such other offices as may be authorized by the Department Convention for such terms appointed by the Department Convention. **Section 4 (b)** The Officers positions listed

in Section 4 (a), elected by the Department Convention shall be nominated and elected for office in the following sequence and for the term of office, as listed: 1. Alternate National Executive Committee member – 2

- Years (on odd number years). 2. National Exec. Committee member – 2 Years (on odd
- National Exec. Committee member 2 Years (on odd number years).
- 3. Department Treasurer 1 Year.
- 4. Department Judge Advocate 1 Year.
- 5. Department Sr. Vice-Commander 1 Year.
- 6. Department Commander 1 Year

REGION CAUCUSES

(ARTICLE V, Sections 6-7-8-9)

A caucus shall be held by each Region during, or not more than twenty days prior to, the convening of each Department Convention, at which caucus the election of the Region Commander, (serves concurrently as Department Vice-Commander for said Region), Region Vice-Commander, District Commanders, District Vice-Commanders such Department Executive Committee members, and Delegates and Alternates to the National Convention of The American Legion to which such Region may be entitled by this Constitution shall be held. It shall be the responsibility of the Region Commander in and for each Region to see that at least fifteen days prior notice of any Region Caucus convened for the above purposes shall be given by mail to the Commander of each Post in the Region, and no such Caucus shall be deemed legally convened in the absence of such notice; provided, however, that any Region may caucus at any Department Convention upon three hours notice by announcement from the Rostrum, and all the purposes of this section may thereafter be fulfilled just as though prior written notice had been given. The action of such Region Caucus as to the election of any of the officials named in this section shall not be final until ratified by the Department Convention.

Section 7. A quorum shall exist at a Department

Convention or at a Region Caucus when one third of the Posts in the Department or Region, as the case may be, are represented by duly elected Delegates or Alternates. Section 8. Delegates to National Convention.

Each Region in Caucus not more than twenty days prior to the convening of the Department Convention shall elect one delegate and one alternate delegate to the National Convention, this delegate and alternate delegate is to represent the first thousand members of their respective Region; there shall also be elected a delegate and alternate delegate for each succeeding thousand members.

The five Department Delegates shall consist of the Department Commander, the Department Commander for the immediate prior year, the Department Adjutant, the Alternate National Executive Committeeman and the Department Senior Vice-Commander who hold office at the convening of the next succeeding National Convention. The alternates for these delegates shall be appointed by the Department Commander.

Any additional delegates and alternate delegates are to be elected by the Region with the highest percentage of their previous year's membership as of the day that determines the Department Convention membership strength for the Region.

Section 9. Region Election of DEC Members.

Each Region in Caucus not more than twenty days prior to the convening of the Department Convention shall elect one representative to the Department Executive Committee for each unit of 500 members or major fraction thereof in the said Region.

The membership strength of said Region for this purpose shall be computed as paid up membership in the Department Headquarters at the close of business on the 35th day prior to the convening of the Department Convention or as of July 1st, in each year, which ever date shall first occur.

In the event any Region shall have less than its first and only unit of 500 members, it shall nevertheless be entitled to elect one representative to the Department Executive Committee.

The distribution of the Regions' representatives to the DEC shall be divided in an equitable manner between the Districts of the Region utilizing the membership strength of each District.

The Region shall submit the names of all elected as above for ratification to the Department Convention such ratification constituting election. At such Caucus each Post shall be entitled to the same number of votes as for the Department Convention. No Region Caucus for the purpose of such election shall be convened sooner than June 25th, 2025.

MEETINGS

The opening Joint Session will begin at 8:00 PM, Tuesday July 15, 2025. All business sessions of The American Legion, Department of Maryland, will be held in the Convention Hall (Roland Powell Convention Center, Bayfront Ballroom, 2nd Floor) and will start promptly at 8:00 AM on Wednesday, July 16th, Thursday, July 17th and Friday, July 18th, unless changed by the Convention or Department Executive Committee. A quorum shall exist at the Department Convention when one-third of the Posts in the Department are represented by a duly elected Delegate or Alternate.

CREDENTIALS CERTIFICATES

For Credentials Certificates for Delegates and Alternates. A check made out to The American Legion, Department of Maryland, at \$20.00* per Delegate, and MUST accompany the Credentials Certificate. All Constitutional Delegates (ART. VI) and Past Department Commanders must also pay the \$20.00* Delegate Fee or they can not vote. It is extremely important that the certificates be forwarded to Department Headquarters as soon as possible after June 10, 2025 (35th Day before the Department Convention). District Commanders should personally check each Post under their supervision to see that the above is complied with. All Post Adjutants are charged with the responsibility of returning the Credentials Certificates to us at the earliest possible moment. The delegate fee shall be *\$30.00 per delegate on or after June 26th.

AMENDMENTS

Amendments to the Department Constitution and

AMERICAN LEGION, DEPARTMENT OF MARYLAND, INC.

By Laws must be submitted in typewritten form to Department Headquarters by June 6th, 2025 in time for the Department Adjutant to forward copies to each Post in the Department at least 30 days prior to the convening of the Convention. These amendments require a two-thirds majority of votes of the representation casting votes on the amendment at the Convention. However, the Constitution may be amended without notice by unanimous vote at any Department Convention. (ARTICLE XV, Section 1).

RESOLUTIONS

Resolutions shall be submitted typewritten, in triplicate, to the Resolutions Committee at the Convention, or prior to June 7th to Department Headquarters. By order of the Department Executive Committee, each resolution MUST have supporting documents and authority attached to each copy. Resolutions submitted to Department Headquarters prior to June 6th will receive preferred attention. Those submitted after that date will be considered only if the Convention Resolution Committee considers them to be of paramount importance to the Legion.

SPECIAL NOTICE

The thirty-fourth Annual Department Convention, 1952, unanimously resolved no one should be allowed on the main portion of the Convention floor on election day except Officers, Delegates, Alternates and working press. (Ref: Resolution #13)

POST OFFICERS

ARTICLE VIII, Sec. 6 of the Department Constitution states, "All Post Officers for the ensuing year shall be elected, or appointed as prescribed in the Post Constitution and Post Standing Rules, at least twenty days prior to the opening of the Department Convention and they shall assume their duties as such within twenty days after the closing date of the Department Convention." YOU MAY HOLD YOUR INSTALLATION PARTY ANY TIME YOU WISH; YOUR POST OFFICERS MUST TAKE OFFICE DURING THE TIME ABOVE STATED. THE DEPARTMENT EXECUTIVE COMMITTEE HAS REQUESTED THAT EACH POST FILE A COPY OF MEMBERSHIP ELIGIBILITY DOCUMENTS FOR EACH POST COMMANDER AND ADJUTANT WITH DEPARTMENT HEADQUARTERS. THE DOCUMENTS WILL NOT BE RETURNED BUT RETAINED IN DEPARTMENT FILES.

REPORTS

- 1. You are urged to promptly file your Certificate of Elections of Post Officers which MUST be signed by both the Post Commander and Adjutant. The Certificate on the bottom of this form means exactly what it says. You MUST EXAMINE the service record of each of your Post Officers to certify their eligibility.
- 2. Consolidated Post Report Form should be filed promptly, but NLT June 6, 2025.
- 3. All other Report Forms. If you have lost or misplaced any of these report forms, send an e-mail or call Department Headquarters and ask for a duplicate.

REGISTRATION

For Tuesday the Registration Desk will be open at the Convention Hall beginning at 7:30 AM, July 15th. DO NOT SHOW UP BEFORE THEN AND EXPECT US TO ACCOMMODATE YOU. IT IS IMPOSSIBLE FOR US TO OPEN EARLIER THAN 7:30AM ON TUESDAY.

NO CREDENTIALS ARE REQUIRED FOR ATTENDANCE AT THE OPENING CEREMONY OR DEPARTMENT LEGION COLLEGE. EVERYONE WILL BE GRANTED ACCESS TO THESE EVENTS WITHOUT CREDENTIALS.

On Wednesday, Thursday and Friday the registration office will open at 7:30 AM. You are urged to pick up your Delegate's Credentials and badges as soon as possible in order to facilitate the business of the Convention. A POST COMMANDER OR ADJUTANT MAY PICK UP THEIR POST DELEGATION REGISTRATION PACKET. ANY OTHER DELEGATE PICKING UP THE POST DELEGATION PACKET MUST PRESENT A WRITTEN AUTHORIZATION FROM THE POST COMMANDER OR ADJUTANTLISTING THEM AS THE AUTHORIZED DELEGATE TO SIGN FOR THE PACKET.

ARTICLE IX, Section 2 of the Department Constitution provides that the amount of annual Department dues shall be determined by the Department Convention. Consequently, we hereby notify you that dues will be set and voted upon as usual by the Department Convention.

of stories written lately about her service and the unit. On her 100th birthday Mrs. Robertson was recognized by the Milwaukee Mayor who attended the celebration, Governor Evers, and then President Biden.

In late April the Speaker of the House will host a ceremony to present the Congressional Gold Medal to the unit's survivors and families. Beyond this occasion through the generosity of U.S. Army Women's Foundation Hall of Fame members and charter donors BG (Ret.) Clara Adams Ender, COL (Ret.) Edna W. Cummings and MSG (Ret.) Elizabeth Helm-Frazier the Army Women's Foundation will award the Six Triple Eight Legacy scholarship for the third time at their event on March 19, 2025. The legacy of the Six Triple Eight will live on through the efforts of these remarkable Veterans and their established legacies. The legacy of service they share with other units who fought not only the enemy but also the racism and misogyny prevalent in the US military during WWI.

On August 25, 2021, President Joseph Biden signed into law the Harlem Hellfighters Congressional Gold Medal Act. The act recognized the service of the 369th Infantry Regiment, nicknamed the Harlem Hellfighters, for their service to the nation during WWI. The New York National Guard unit established in Harlem in 1913 was one of the earliest units sent overseas to serve in WWI. Facing prejudice and segregation the unit was attached to fight with the French Army instead of serving with US Forces in France. The unit embraced their mission and cemented their legacy through their service.

The 369th spent an unprecedented 191 days in the front line trenches and the Regiment was the first American unit to receive the French Croix de Guerre (War Cross) and its soldiers bravery in combat are legendary. Sgt Henry Johnson distinguished himself in battle in May 1918 and for his battlefield valor Johnson became one of the first Americans to be awarded the French Croix de Guerre avec Palme, France's highest award for valor. Johnson returned home from his tour and was unable to return to his pre-war porter position due to the severity of his 21 combat injuries. Johnson died in July 1929. He is buried in Arlington National Cemetery in Arlington, Virginia. He was posthumously awarded the Purple Heart in 1996 and the Distinguished Service Cross in 2002 Finally in 2015 he was awarded posthumously the Medal of Honor for actions in WWI by President Barack Obama in 2015 97 years after his heroic actions The Medal of Honor battle narrative reads:

Area of Operations - Argonne Forest, Champagne, France; Position – Sentry; Date of Action May 15, 1918

"Then-Pvt. Henry Johnson served as a member of Company C, 369th Infantry Regiment, 93rd Division, American Expeditionary Forces, during

combat operations against the enemy on the front lines of the Western Front in France.



While on night sentry duty, May 15, 1918, Johnson and a fellow Soldier, Pvt. Needham Roberts, received a surprise attack by a German raiding party consisting of at least 12 soldiers.

While under intense enemy fire and despite receiving significant wounds, Johnson mounted a brave retaliation resulting in several enemy casualties. When his fellow Soldier was badly wounded, Johnson prevented him from being taken prisoner by German forces.

Johnson exposed himself to grave danger by advancing from his position to engage an enemy soldier in hand-to-hand combat. Wielding only a knife and being seriously wounded, Johnson continued fighting, took his Bolo knife and stabbed it through an enemy soldier's head.

Displaying great courage, Johnson held back the enemy force until they retreated. The enemy raid's failure to secure prisoners was due to the bravery and resistance of Johnson and his fellow comrade. The effect of their fierce fighting resulted in the increased vigilance and confidence of the 369th Infantry Regiment".

The va.gov news story about the unit's award of the Congressional Gold Medal marks the legacy of the unit in these words, "Upon their return to the United States, the Harlem Hellfighters received a hero's welcome, yet they continued to face the harsh reality of injustice. Nonetheless, the regiment's service in World War I marked a significant milestone in fighting for civil rights and equality. Their actions paved the way for future generations of African American soldiers and contributed to the eventual desegregation of the U.S. military. The 369th Infantry Regiment will forever be remembered as pioneers of change and defenders of liberty."



Another WWI unit overlooked for years for their service recently were recognized when President Joseph Biden signed the latest National Defense Authorization Act on December 24, 2024. When US troops were being deployed to the European Theater in the early stages of involvement in WWI by the United States General John Pershing urged the US Army Signal Corps to recruit women to be trained and operate a vital communication network. The effort was meant to show that women had a role on the war front overseas not just at home. The result was the recruiting of approximately 300 women many who were bilingual in French and English. They were the country's first effort to place women in the hazardous areas in combat theaters and they popularly known as Hello Girls. They paved the way for women to serve and though they were told afterwards their service did not count as Veterans they served with distinction and proved that everyone had a place in the war effort. One of the women who

One of the women who volunteered for service was Marie Edmee LeRoux. Marie was born in Montreal and moved to the US at the age of 10. She is buried in Fort Lincoln Cemetery in Brentwood, Maryland in an unmarked grave as the War Department at the time still did not classify the Hello Girls as Veterans.

Congress in 1977 acknowledge the women as Veteran, but sadly many had already passed. With the NDAA passage in December 2024 the Hello Girls are receiving long overdue recognition and we will update on the progress of the recognition for these pioneer Veterans of WWI.

Over the last six years the process to highlight a few personal stories and deeds of Veterans has started many conversations. The continuation of these conversations and the development of a better understanding of the impacts these men and women had on the world around them is still far from complete. There are many more personal stories, and Post histories, one could highlight in these articles. It is tough to not only fit the stories in the brief space available but then to pick which stories to highlight. There are so many stories to tell, and next year we will surely recount more of these deeds. My hope is to spark the efforts to save these memories for posterity and promote a celebration of a part of our history that is not as familiar as many other aspects. The elevation of these stories and history shows the proud traditions, and clearly answers the question of why the members would want to maintain their heritage.

The recounting of the actions and works of the heroes from this article can serve as a reminder that many served and were never appropriately recognized. Striving to educate and illuminate the deeds of a few is a calling for all to preserve the memories and incidents of our associations in all wars.

It is past time to make this a constant effort to promote all Veterans' contributions, and share the history, good and bad, to highlight the proud history of the African American Veterans and the accomplishments shared with the Department of Maryland. The way ahead is lit brightly by their deeds and the inclusion of all Veterans is the solid foundation for the future!

This care also extends beyond the state of Maryland. As America's largest integrated health care system, VA has more than 1,320 facilities throughout the country. Regardless of where Veterans are enrolled, they'll have access to services at any of these VA health care facilities, providing extra convenience when they travel or move.

A unique benefit of VA health care enrollment is access to a variety of community care resources. Veterans who see their VA primary care provider at least once every two years maintain their eligibility for the following community care resources: Emergency care services in the community at VA expense; Urgent care through participating community urgent care facilities; and Care in the community at VA expense based on specific eligibility criteria and a referral from a VA provider.

How to Apply

There are four easy options to apply for VA health care:

Apply by Phone

Call toll-free at 877-222-8387, Monday through Friday between 8 a.m. and 8 p.m. A VA staff member will collect the needed information to process your application over the phone.

Apply by Mail

Visit www.va.gov/find-forms/about-form-10-10ez/ to print and complete the Application for Health Benefits (VA Form 10-10EZ). You or someone acting as your power of attorney must sign and date the form. Once completed, mail your application to: Health Eligibility Center PO Box 5207, Janesville, WI, 53547-5207.

Apply in Person

Apply in person by visiting the Enrollment Center on the 1st floor of the Baltimore VA Medical Center or the Admissions Office on the 1st floor of Building 361 at the Perry Point VA Medical Center, Monday – Friday between 8 a.m. to 4 p.m.

Apply Online

Apply online by visiting www.va.gov/ health-care/apply-for-health-care-form-10-10ez/introduction. The online portal will guide you through each step of the process and will take about 35 minutes to complete.

You can also receive ongoing information from the VA Maryland Health Care System to learn about new programs and services, educational opportunities, and upcoming events such as our quarterly Veterans Claims Clinics & VA Health Care Enrollment Fairs. 

VETERAN'S BENEFITS ADMINISTRATION PREPARE FOR VA'S SECURE SIGN-IN CHANGES

To continue to protect Veterans' identities and benefits, VA is making changes to its online sign-in process. In 2025, you'll need to use a Login.gov or ID.me account to sign in to all VA websites and apps, including My HealtheVet. VA will remove the My HealtheVet sign-in option after March 4, 2025, and the DS Logon option after September 30, 2025. If you don't have one of these accounts yet, VA encourages you to create one now. Both Login.gov and ID.me require multifactor authentication (MFA) as part of the account set-up process. This extra layer of protection helps VA make sure that it's you trying to use your sign-in account and not someone pretending to be you. Multifactor authentication is a common practice for many websites and apps. You may already use it to access your email, bank account, or social media accounts.

When you set up your Login.gov or ID.me account, you can choose the multifactor authentication option that works best for you.

This account allows one to sign in to VA.gov, VA mobile apps, and any other VA online service. One can manage and stay up to date on VA Benefits and VA Healthcare on this applications and sites.

Post 9/11 Veterans who also served a qualifying period for the Montgomery GI Bill please pay close attention!! VETERANS MAY BE ELIGIBLE FOR ONE MORE YEAR OF G.I. BILL BENEFITS - Impact of Rudisill Supreme Court Decision on Veterans' Education Benefits

On April 16, 2024 the Supreme Court of the United States decided that if you served at least two periods of service-one that qualifies for the Montgomery GI Bill (MGIB) and another that qualifies for the Post-9/11 GI Bill (PGIB) you may be able to receive additional GI Bill benefits.

Aged 45 or older? Get screened for colorectal cancer at home with a FIT test. Talk to your VA provider or civilian primary care doctor about the risks and need for regular screening. Colorectal Cancer is one of the most diagnosed

Screening is crucial to detect cancer early, when treatment is most effective

Colorectal cancer (CRC) is cancer in the colon or rectum. It's a leading cause of cancer deaths in the U.S. But when this cancer is found and removed early, the chances of a full recovery are very good. Because colorectal cancer rarely causes symptoms in its early stages, screening for the disease is important. Many abnormal growths (e.g., polyps or cancers) in the colon bleed. A fecal immunochemical test (FIT) is a screening done at home that checks for blood in stool that you can't see. Screening with FIT can catch cancer and polyps early.
